The Operation School Bell program provides appropriate school clothing, shoes, hats, gloves and hygiene kits for K thru 12 students in need of help purchasing clothing in the Klamath Falls City School District, the Klamath Falls County School District and the Tulelake School District located in Northern California. In 2015-16, 821 students were clothed. Each of the eleven high schools received three \$100 clothing certificates to be issued to graduating seniors that needed assistance in purchasing appropriate graduation clothing as well as when searching for a job. These graduating students were selected by school counselors. Award Winning books were distributed to all schools participating in our Operation School Bell program (K thru 12) and eleven Klamath County Libraries.

Families in Crisis Program provides disposable diapers, wipes and bus tokens to the Klamath County Crisis Center as needed. Holiday treats and gifts are also given.
