The organization continues to consult with women in unplanned or crisis pregnancy situations. For the current fiscal year the entity had 1895 client appointments, provided approximately 340 pregnancy tests, over 230 ultrasound exams, distributed materials and supplies to approximately 437 individuals and had over 874 education and pregnancy consultation appointments. The organization continues to provide free services to the local communities as demanded and has continued to fill ongoing needs for pregnancy consultation services.
