For the current fiscal year the entity had over 1200 client appointments, provided approximately 326 pregnancy tests, over 160 ultrasound exams, distributed materials and supplies to approximately 254 individuals and had over 560 education and counseling appointments. The organization continues to service the local communities as demanded and has continued to fill ongoing needs for pregnancy consultation services.
