BUSINESS ENTREPRENEURIAL CENTER PROGRAM IN CONJUNCTION WITH ROGUE COMMUNITY COLLEGE (RCC), THE IVCDO IS MANAGING A BUSINESS EDUCATIONAL AND MENTORING CENTER IN KERBY, OR. THE "BUSINESS ENTREPRENEURIAL CENTER" (BEC) BRINGS THE RESOURCES OF THE RCC'S SMALL BUSINESS DEVELOPMENT CENTER TOGETHER WITH THE ECONOMIC AND COMMUNITY DEVELOPMENT CAPACITY OF THE IVCDO TO PROVIDE A WIDE RANGE OF BUSINESS SERVICES.
