DURING THE 2021 BUDGET SESSION, THE OREGON STATE LEGISLATURE PASSED SEVERAL PACKAGES TO INCREASE THE PRODUCTION AND PRESERVATION OF AFFORDABLE HOMES, INCLUDING A DOWN PAYMENT ASSISTANCE PACKAGE AND THE CREATION OF A STATEWIDE FUND FOR HOMEOWNERSHIP DEVELOPMENT. LEGISLATORS ALSO PASSED ALLOCATIONS FOR LAND ACQUISITION, CONSTRUCTION, LOANS, A HOME REPAIR FUND AND WILDFIRE RECOVERY. ALONG WITH THE OREGON HOME BUILDERS ASSOCIATION, HABITAT OREGON SUCCESSFULLY CO-LED LEGISLATION TO PROMOTE THE DEVELOPMENT OF SO-CALLED "MISSING MIDDLE" HOMES FOR SALE, INCLUDING DUPLEXES, TRIPLEXES, QUADS, COTTAGE CLUSTERS AND TOWNHOMES.DISASTER RISK REDUCTION AND RESPONSE: HFHO PROMOTES AWARENESS OF THE POTENTIAL IMPACT OF DISASTERS IN AFFILIATE SERVICE AREAS, PROMOTES RISK REDUCTION, ASSISTS AFFILIATES WITH DEVELOPING A CONTINUITY OF OPERATIONS PLANS AND PARTICIPATES IN STATEWIDE RECOVERY PLANNING. THIS BODY OF WORK IS A COMBINATION OF INFORMATION SHARING AND TRAINING WITH LOCAL AFFILIATES--AS WELL AS PARTICIPATING THROUGH OUR STATE VOAD: OREGON VOLUNTARY ORGANIZATIONS ACTIVE IN DISASTER.
