Once they turn 18, young people are legally classed as adults, but many 18-year-olds are still in high school, and few are able to be completely self-supporting. This age group is still developing and needs support to transition into adulthood. The youth we serve in our Next Steps program have little or no support from parents or other family, we provide secure housing for these vulnerable youth while they complete secondary school (or obtain a GED) and prepare for higher education, vocational training, or employment. Our Next Steps program offers Housing in a dorm/apartment-style setting, Financial support for education, counseling, health care, and transportation, Case management emphasizing the skills, resources, and community connections needed to live independently, Skills training on topics such as relationships, health/fitness, communication, budgeting/savings, drugs and alcohol, and meal planning, and Coaching to help find and maintain quality employment. Last year 13 youth stayed at our "Next Steps" houses, for a total of 2,290 nights.
