OTHER PROGRAM SERVICES INCLUDE: VIRTUE - IS A THIRTY-SIX-WEEK PROGRAM FOR WOMEN WHO HAVE EXPERIENCED DOMESTIC VIOLENCE BUT WHO ALSO HAVE USED ABUSIVE BEHAVIORS THEMSELVES. THE PROGRAM PROVIDES CLIENTS WITH BOTH HEALING FOR THE ABUSE THEY HAVE SUFFERED AS WELL AS ACCOUNTABILITY AND TOOLS TO HELP THEM DEAL WITH CONFLICTS IN A NON-ABUSIVE MANNER. THE PROGRAM SERVES THE TRI-COUNTY AREA AROUND PORTLAND, OREGON. MOST OF THE CLIENTS ARE RECEIVED AS REFERRALS FROM COMMUNITY CORRECTIONS OFFICIALS OR DEPARTMENT OF HUMAN SERVICE WORKERS, BUT ALSO HAVE WOMEN WHO VOLUNTARILY ENTER THE PROGRAM TO BETTER THEMSELVES. FOUNDATIONS - IS AN INTERACTIVE PROGRAM FOR YOUNG WOMEN AND MEN AGES 12-22 TO PROVIDE THEM WITH THE TOOLS TO RECOGNIZE HEALTHY AND UNHEALTHY RELATIONSHIPS AND BEHAVIORS. ARMS HAS BEEN ASKED BY MULTIPLE COUNTY AGENCIES TO OFFER THE PROGRAM TO THEIR YOUTH. COMMUNITY IMPACT - IS AN OUTREACH PROGRAM DESIGNED TO HELP EDUCATE THE COMMUNITY ABOUT DOMESTIC VIOLENCE AND ABUSE. ARMS HOLDS THREE LUNCHEONS A YEAR THAT PROVIDE A SAFE PLACE FOR VICTIMS ALONG WITH THEIR FRIENDS AND FAMILY MEMBERS TO BEGIN THEIR JOURNEY TOWARD HEALING. THE PROGRAM ALSO INVOLVES BOTH SECULAR AND RELIGIOUS TRAININGS PROVIDED TO THE COMMUNITY. ARMS IS AN ACTIVE MEMBER IN THE LARGER COORDINATED COMMUNITY RESPONSE TO DOMESTIC VIOLENCE AND IS SEEN AS EXPERTS IN DEALING WITH THIS ISSUE FROM A FAITH PERSPECTIVE.
