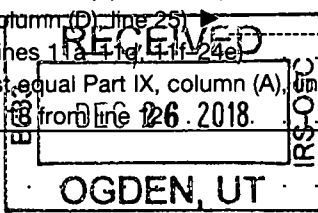

 The City Repair Project is an organized group action organization that educates and inspires communities and individuals to creatively transform the places in which they live. We facilitate artistic and ecologically - oriented peacemaking through projects the honor the interconnection of human communities and the natural world.

 Village Building Convergence — This is City Repair's flagship program for providing our technical expertise for community place-based projects. This program was first formalized in 2000 and has grown from servicing just 1 project along with a neighborly style potluck and music jam to over 30 projects across Portland and over two dozen inspirational speakers, practitioners and artists. Now in it's 19th annual cycle, the VBC is world renowned as one of the largest urban grassroots ecosocial festivals there is. Travellers ranging from off-grid renegades to Japanese government officials visit us every year to cross-pollinate best practices for citizen engagement and quadruple bottom line ethics (people, profit, planet and purpose). Beyond being the most effective mechanism we have for galvanizing 30 neighborhood-based projects annually, the VBC also attracts and empowers hundreds of volunteers across its various subprograms ranging from a central venue for the evening programming to the day-time community projects spread all over the city. Modelled after the ecosocial life pattern of the springtime barn-raiser, this 10-day event is one of our most effective tools for empowerment and education.

 Events — This department hosts events ranging from our largest annual fundraiser Howl as well as smaller events that we offer community building services at including Pickathon music festival and the occasional speakers/workshops that we host to generate awareness about topics that inspire people to more deeply inhabit and tend to the places that they live, work and play in. For example, we've hosted internationally acclaimed authors and ideators like Charles Eisenstein, Starhawk and Jon Young covering topics like Sacred Economics, Regenerative Living and Nature Connection through Bird Language and Mentorship. We also host a variety of social gatherings to help weave a closer web of relationships between the people we inspire and conspire with for creative projects of various scales.

 Custom Services — After the VBC, this department is another heavy weight and helps us customize our services to fit community needs that fall outside of the VBC framework. This also allows us greater agility in providing a fuller range of our services since we are not convening more than a few community sites at a time as opposed to over 30 sites with the VBC. Projects in this department have ranged from consulting with a group of Girl Scouts in Oregon City on a park redevelopment plan to working with county, partner nonprofits, service providers, advocates and houseless folks to design and build villages for folks experiencing housing insecurity. Some of our larger educational programs like the Urban Permaculture Design Course and the Village Building Design Course also fall within this department. We also work with communities for Open Streets events in public by bringing our art vehicles out to provide strong aesthetic and visual presence while offering opportunities for engagement. We do this by setting up activities, distributing free tea/lemonade and sometimes even plants, and keeping things cozy and comfortable for people to lounge around, relax and connect with each other.
