HOC operates five job skills and educational programs: AmeriCorps, YouthBuild, Central Oregon Youth Conservation Corps, Stewardship, and a Heart of Oregon Thrift Store. Although each of our job skills programs has their own distinct outcomes, our organization-wide goal for each and every opportunity youth we serve stays constant. We are dedicated to providing our young people with jobs skills training, wages for hard work, opportunities for educational advancement at secondary and post-secondary levels, leadership development, and a pathway out of poverty. Since 2000, HOC has demonstrated its capacity by employing more than 2,000 local youth. Over the past 5 years, HOC has paid more than \$6 million in wages and stipends and awarded \$750,000 in scholarships to youth who have contributed over 400,000 hours of service to community improvement projects.
