SINCE 2004, VOLUNTEERS IN MEDICINE CLINIC OF THE CASCADES (VIM) HAS CARED FOR LOW-INCOME, UNINSURED ADULTS BY UTILIZING THE COLLABORATIVE POWER OF MEDICAL AND NON-MEDICAL VOLUNTEERS. PATIENTS ARE OVER 18 YEARS OF AGE AND HAVE INCOMES OF LESS THAN 250% THE FEDERAL POVERTY LINE. MOST ARE WORKING ADULTS WHO ARE CURRENTLY INELIGIBLE FOR AFFORDABLE CARE ACT PROGRAMS. CARE IS PROVIDED ON A DONATION BASIS, THROUGH OVER 300 VOLUNTEERS IN THE CLINIC, ALONG WITH OVER 400 COMMUNITY MEDICAL PARTNERS.
