ONE-TO-ONE COUNSELING, CRISIS INTERVENTION, SKILL-BUILDING, AND TWICE DAILY THERAPEUTIC GROUPS ARE PART OF THE PROGRAM STRUCTURE PEOPLE ENGAGE WITH TO SUPPORT IN THEIR PATH TO RECOVERY AND WELLNESS.
