

This agency offers a childcare program to low income and at risk families who qualify by income and need, as determined by the California Department of Education. Families are enrolled from a County wait list, based on an income ranking and family fee system, set forth by the California Department of Education. Care is provided by licensed Family Childcare Providers, who are recruited and contracted with the agency. Preschool is also offered to these children. These children are served for 249 days per fiscal year. The agency also operates private Montessori Preschool program, which has an enrollment of 135-150 part time students. The program operates September to June: with an additional 8 week summer school class. We offer classes for children 2 years to 5 years of age. The agency supports parents by offering workshops, parenting resource library, and a full-time Licensed Clinical Social Worker.
