The Workforce Innovation and Opportunity Act (WIOA) is designed to provide job training and employment opportunities to those low income individuals and other individuals who face serious barriers to employment and who are in special need of such training to obtain and maintain productive employment. In addition to services provided under the Comprehensive Services Plan (CSP), services were provided to youth participants under the Supplemental Youth Services (SYS) Program. Transitional funding was received to provide information and guidance to staff, advisory council, and board members regarding the transition from the Workforce Investment Act (WIA) to WIOA funding. Services also were provided under the WIOA Career Pathways for Youth (CPY) program, a two-year program for youth with little to no work history.

4b (Code ) (Expenses \$ 728,476 including grants of \$ ) (Revenue \$ )
The Native American Elders and Caregiver Support Programs provided services to Indian elders residing on sixteen (16) reservations and Rancherias. During the program year ending March 31, 2017 a total of 4,647 meals were served in a congregate setting and another 31,458 meals were delivered to participating elders, their spouses, and program volunteers. The program also brings elders together for cultural activities. The Caregiver Support Program is designed to provide respite care for caregivers of Indian elders and for elders who are themselves caregivers for their grandchildren. Caregiver training classes also are held, with 79 tribal members attending a 26-hour basic caregiver and 8-hour CPR First Aid class. Funding through the Medicare Improvements for Patients and Providers Act was used to provide training for 75 elders during the program year.

The Child Care and Development Block Grant Program provides payment for child care services for eligible families. Parents choose their child care provider. Once a provider is registered with the program child care services can be provided and payments can be made. During the program year ending June 30, 2017, 82 children from 47 families received services. The program also conducts resource and referral and quality improvement activities designed to improve the quality of child care services performed by child care providers.
