PROGRAM ACCOMPLISHMENT In the last ten years, Main Street Launch has made loans totaling \$54 million to 617 businesses, creating and sustaining over 5,000 jobs. These loans supported 50% women-owned businesses, 72% businesses owned by low-to moderate income (LMI) entrepreneurs, 51% minority-owned businesses, 60% businesses in LMI neighborhoods, and 54% new businesses.
