In 2016, we served 15,244 individuals and gave away enough food for 182,928 meals. In addition, thanks to the generosity of several local grocery stores we provided fresh produce to our clients. We thought our demand might go down due to the improvement of the economy, but that has not been the case. The demand has remained pretty much the same. Although we have to purchase a large quantity of the food we give away, we receive food donations from churches, organizations and individuals.
