The Academy layered credits over attendees at the August 30th Tribal Symposium (16 given credit), CDFA Roundtable October 12th (11 given credit) and the Southern Symposium on March 28th (8 given credit). Additional there was a standalone Academy offering with two courses (Modules 2 & 3) on March 15, 2018 (48 given credit in both classes). The Academy has raised the number of AZED Pros graduates to 46. AAED held the 6th year of the AZ Basic Economic Development Course (January 22-26, 2018) with 44 graduates. The Ben Warren Scholarship for 2018 was awarded to Carol Treuber of Southeast Arizona Economic Development Group. Continued a partnership with IEDC to bring CECD classes to Arizona which includes revenue sharing with AAED in 2018. MOU entered to bring the Real Estate Development and Reuse course to Arizona November 1-2, 2018. AAED has partnered with Colorado and New Mexico to provide two additional courses and a CECD exam to the region in 2018. Advocacy efforts and accomplishments included: Creating AAEDs legislative policy priorities to give to state elected officials, Directing the Associations lobbying efforts at the capitol, Held a Policy Impact Dinner January 22, 2018 with 120 attending including 45 elected officials. Spring Conference, The Future is Now: Setting Arizonas Trajectory, held May 2-4, 2018 at the Hilton El Conquistador, Oro Valley with 182 registered to attend. Created and planned the second Fall Forum October 25-27, 2016 at the Prescott Resort, 145 attendees, 10 Golden Prospector Awards presented with 7 Awards of Merit. Partnered with Arizona Rural Development Council to conduct a session at the Rural Policy Forum in Thatcher, Arizona on August 10, 2017. Continued a partnership with AZRE Magazine to create a separate AAED supplement for the November/December 2017 issue and to produce 5 legislative editorials this fiscal year. Entered into the fourth-year partnership with Council of Development Finance Agencies (CDFA) to provide financial training in Arizona to AAED members at a reduced rate & to allow participation in development of course offerings. Assisted in the planning and promotion of Financing Roundtable and CDFA Annual Conference went so well they returned to Arizona on October 12, 2017 at the Hotel Tucson City Center. Planning for 2018 is underway for an October session in Phoenix. Planned and conducted 11 monthly luncheons in Phoenix with one Workforce Symposium. Luncheons thus far this year are averaging 97 attendees with 106 attending the symposium. Planned and conducted 5 luncheons in Southern Arizona and one symposium. Luncheons thus far this year are averaging 55 attendees with 61 attending the symposium. Planned and conducted one luncheon and two Northern Arizona Economic Development Regional Symposiums. The first symposium was held February 28th in Wickenburg (74 attendees). The second, Medical Tourism, held in Cottonwood June 21st with 87. A mayoral luncheon was held in Prescott, April 19th with 70 in attendance. Planned and conducted a Western AZ Roundtable on August 16th in Parker, AZ with the Rural Committee (85 attendees) and a Northern AZ held in Flagstaff, May 15th (100 attendees). Seven electronic newsletters called The Voice were distributed. The 3rd annual Cornhole fundraiser on February 9, 2018 at the Pera Club in Tempe, Arizona was a sell out with 60 teams (240 participants) plus 30 spectators.
