The top three candidates are then selected and the winning applicants are notified via email. The supporting organization then disburses the funds in accordance with the recipient's instructions. Disbursements for general program support are monitored for receipt by Junior Achievement of Arizona, Inc. and used where needed to provide programs to K-12 students.
