The activities carried out are those necessary to plan, direct, manage, coordinate, promote and implement the program to build homes for families selected for participation in the program. Until a home is completed and sold, expenses to rennovate the home are coded to construction in progress. Therefore, the expenses balance above understates the actual program expenses during the year.
