The agency also provides an array of group and specialty services for families including therapy and parenting classes. Participating families are referred through the courts, county health and social services, schools, law enforcement, teachers and other community providers. The agency has two facilities in Fairfield and one in Vallejo. Child Haven served 734 children and their families in this fiscal year.
