During that period we received 3,792 calls representing 4,909 potential tenants who were looking for a home they could afford. The Community Housing Partnership (CHP) had a turnover of 61 units out of 149 during the fiscal year that ended June 30, 2018. From its inception The Community Housing Partnership has not only provided housing for low income families and single individuals but has also assisted our renters, along with the community, in retaining their housing. This has resulted in referring services that may be of assistance to our renters, as well as to other residents in their communities.
