Habitat-Spokane builds homes with families in need in Spokane County.

Families work beside the volunteers to help build their homes.

Each family must put in 500 hours of work of sweat equity to build their homes.

Families who are selected for our program must meet our requirements, which are as follows:

1. Currently living in inadequate housing (Unsafe, overcrowded, subsidized paying more than 30% of your income for housing).

2. Earn between 25% - 80% of the area median income for Spokane County, meet creditworthiness requirements, and save \$3,000 for closing costs.

3. Willing to partner with Habitat-Spokane

4. Willing to put in 500 hours of sweat equity

Habitat-Spokane tithes up to 10% of proceeds to Habitat for Humanity International for support of international builds in 3rd world countries.

Provide 0% interest loans to families we serve.

Homes are sold to families at or below the cost of building their home with mostly donated labor.

The built-in-equity in the home due to volunteer labor is included in a 2nd mortgage or shared equity agreement.

The 2nd mortgage is forgiven at a rate of 5% for each year the family lives in the home.

The 2nd mortgage only needs to be paid if the family relocates, refinances or sells their home.

Mortgage terms are based on family income.

Mortgage payments include principal, property taxes, and insurance.

Mortgage payment amounts are kept at or below 30% of family income.

The principal payments received from current homeowners are used to build homes for future homeowners.

The sale of donated materials at a discounted price at our Habitat Store.

The donation of material to our Habitat Store helps decrease the amount of materials that end up in landfills.

These funds are held in a designated Trust non-interest bearing bank account.

Habitat for Humanity collects a security deposit from Lessees. If lessee performs all lessee's obligations Habitat will return the deposit, without interest but is not required to keep said deposit separate from its general accounts, per the lease agreement.

Part V, Line 4: Habitat Spokane established and funded the Habitat for Humanity-Spokane Endowment Fund. It is intended to encourage donors who wish to make a long term investment in the affiliate's good works with distributions going to the affiliate. It is managed by the non-profit Inland Northwest Community Foundation as a reciprocal transfer under FASB statement ASC 958-605
