Home construction, repairs, and/or rehabilitation for low income families by using donated labor and materials. Habitat-Spokane builds homes with families in need in Spokane County. Families work beside volunteers to help build their home. Each family must put in 500 hours of work (sweat equity) to their home. Families selected for our program have met the following requirements:

- 1. Currently living in inadequate housing (unsafe, overcrowded, or subsidized paying more than 30% of their income).
- 2. Earn between 25% - 80% of the area median income for Spokane County and meet creditworthiness requirements, and save \$4,000 for closing
- 3. Willing to Partner with Habitat-Spokane

The Habitat Store --

A retail thrift store that sells donated furniture, fixtures, hardware and a variety of building materials at a discounted price to the public. This reduces waste in the community and lowers the amount of discard building materials ending up in landfills. The Habitat Store also provides an additional way for volunteers to serve their community. Habitat families are able to earn some of their hours at the store. The net proceeds from the Habitat Store are used by the affiliate to build homes for families in need.
