HDC provides collaborative settings and opportunities for nonprofit developers and others to increase affordable housing HDC works closely with government, environmental advocates and community coalitions to raise the awareness of the broad benefits of affordable housing and to implement sound public policies that lead to increases in the quantity and quality of such housing throughout King County Recent accomplishments include HDC's Policy/Advocacy team successfully worked to fund affordable homes by helping to pass King County Affordable Housing Bonds legislation, secured increased allocations to the ARCH Housing Trust Fund, helped secure a \$75 million Washington Housing Trust Fund investment, negotiated historic equitable development investments as part of Sound Transit 3, and adoption of a new local funding option for affordable housing capital, operations, maintenance, as well as mental health facilities and services
