ABODE OFFERS TWELVE HOUSING PROGRAMS LINKED TO SUPPORT SERVICES TO ASSIST HOMELESS FAMILIES AND INDIVIDUALS IN ESTABLISHING STABILITY AND INDEPENDENCE. HOUSING OPTIONS INCLUDE EMERGENCY SHELTER PROGRAMS, RENTAL SUBSIDIES, TRANSITIONAL HOUSING AND PERMANENT SUPPORTIVE HOUSING. SUPPORT SERVICES CONSIST OF INTENSIVE CASE MANAGEMENT, JOB COUNSELING AND PLACEMENT REFERRALS, LIFE SKILLS TRAINING, MONEY MANAGEMENT, PARENTING CLASSES, CHILDREN'S PROGRAMS, BENEFITS ACQUISITION, PRIMARY AND MENTAL HEALTH CARE SERVICES, AND INDIVIDUAL AND GROUP SUBSTANCE RECOVERY COUNSELING.

SCATTERED SITE HOUSING AND SUPPORTIVE SERVICES. OUR PROGRAMS INCLUDE CLOSE TO 40 SUPPORTIVE HOUSING PROGRAMS, INCLUDING MORE THAN 970 SCATTERED-SITE UNITS. EACH NIGHT WE PROVIDE HOUSING STABILITY TO MORE THAN 1,500 HOUSEHOLDS. WE PROVIDE A COMPREHENSIVE RANGE OF HEALTH AND WELLNESS PROGRAMS AND OTHER WRAP-AROUND SUPPORTIVE SERVICES THAT PROMOTE HOUSING STABILITY, INCLUDING INTENSIVE CASE MANAGEMENT, CRISIS INTERVENTION, MENTAL HEALTH CARE, AND OTHER THERAPEUTIC INTERVENTIONS FOR CHRONICALLY HOMELESS AND AT-RISK POPULATIONS. TARGETED PROGRAMS INCLUDE SERVING YOUNG PEOPLE AGING OUT THE FOSTER CARE SYSTEM, VETERANS, FAMILIES, HOMELESS ADULTS WITH SEVERE MENTAL ILLNESS, PEOPLE RE-ENTERING FROM CORRECTIONAL FACILITIES, AND MANY OTHER SUB POPULATIONS. THE MAJORITY OF THESE PROGRAMS ARE FOCUSED IN SANTA CLARA AND ALAMEDA COUNTIES.

SHELTER AND OUTREACH SERVICES PROVIDES SERVICES TO PEOPLE CURRENTLY EXPERIENCING HOMELESSNESS IN AN OUTREACH SETTING OR WITHIN OUR EMERGENCY HOMELESS SHELTER. SERVICES INCLUDE ENGAGEMENT WITH PEOPLE LIVING ON THE STREETS, CONNECTIONS TO BENEFITS AND HOUSING. WHILE IN THE SHELTER, PEOPLE ARE PROVIDED WITH MEALS THREE TIMES A DAY, INTENSIVE CASE MANAGEMENT, LIFE SKILLS TRAINING, JOB COUNSELING, AND OTHER SUPPORT TO ENABLE SUCCESSFUL TRANSITION TO MORE STABLE HOUSING AND GREATER INDEPENDENCE. SHELTER AND OUTREACH SERVICES PRIMARILY PERFORMED IN SOUTHERN ALAMEDA COUNTY.

SUPPORTIVE HOUSING PROJECTS PLACE AND SUPPORT PEOPLE EXPERIENCING HOMELESSNESS INTO PERMANENT HOUSING WITH DIRECT SUPPORTS TO ASSIST THEM IN MAINTAINING HOUSING STABILITY. WHILE IN HOUSING OUR STAFF PROVIDES RESIDENTS WITH HOUSING RETENTION FOCUSED CASE MANAGEMENT, HELPING THEM UNDERSTAND THEIR LEASE AND HOW TO BE GOOD TENANTS. ADDITIONALLY WE WORK WITH HOUSEHOLDS TO INCREASE THEIR SELF SUFFICIENCY, JOB TRAINING SKILLS, AND ACCESS HEALTH AND OTHER PUBLIC BENEFITS SO THAT THEY ARE ABLE TO GAIN THE SKILLS NECESSARY TO PREVENT ANY RETURN TO HOMELESSNESS. SERVICES ARE PROVIDED IN SITES THAT ARE BOTH OWNED BY ABODE, ABODE AFFILIATE ORGANIZATIONS, AND OTHER DEVELOPERS WITHOUT ANY OWNERSHIP CONNECTION TO ABODE.
