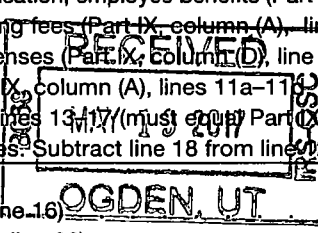

Total Revenue is \$9,171 (the value of the items given to low-income individuals) + \$25,711 (Sale of danated items) =\$34,882.
