Safe Schools student leadership conference is a collaborative effort between SNG, Seattle University, Seattle Police Department, and Seattle Public Schools designed for high school students in leadership or peer influence positions. We place youth in paid internships at participating agencies in the private and public sector, provide a full training day along with educational field trips for the cohort weekly.
