These positions are compensated at 85-115% of the median rate for like positions in similarly sized nonprofit organizations in the San Francisco Bay Area. To the extent like-organization benefits information can be obtained, it is considered part of the overall compensation package for the purpose of comparison with other similarly-sized nonprofit organizations. As an alternative, the most recent publication of the Public Sector & Public Interest Attorney Salary Report, published by NALP may be used if it segregates salary information by years of service, size of metropolitan region, and by region. Compensation based on this report must be 85-115% of the median. The Executive Director's compensation is set within the above range by the Co-Chairs of the Board of Directors. Compensation for other persons is set by the Executive Director within the above range, subject to approval by the Co-Chairs of the Board of Directors. Other than its Executive Director, ALRP does not have any paid employees who meet the IRS's definition of officer or key employee.
