Specific accomplishments include: Good Sams Vision Academy afterschool program in the Bayview district, which focuses on elementary age youth, reported a Homework Completion Rate of 95% - which is one of our academic measurements, Good Sams Willie Brown Beacon afterschool, also in the Bayview was voted the most improved school in San Francisco Unified School District, and Good Sams Newcomer services team continued to expand their effort to reach newly arrived immigrant youth and due to their positive impact on SFUSD campuses, was asked by the school district to implement 7 more Newcomer support groups at local high schools.

Early Childhood Development Services Good Samaritan provides a Title V licensed preschool providing a Spanish-English dual language curriculum to support the development and learning for 52 children 3-5 years old. Children who were non-English speakers when they enrolled left prepared to enter English-only Kindergarten, and English-only children to enter bilingual Kindergarten. The program had passed three different State quality-monitoring evaluations. The program maintained its 4 star out of 5 in the State Quality Improvement Rating Scale, and remained in the high-mid levels for the student interactions (CLASS) and environment (ECERS) standards.
