

THE COMMITTEE RECEIVES DATA FROM THE ANNUAL NORTHERN CALIFORNIA COMPENSATION & BENEFITS SURVEY CONDUCTED BY NONPROFITS COMPENSATION ASSOCIATES ALONG WITH DATA FROM THE ANNUAL EXECUTIVE COMPENSATION SURVEY CONDUCTED BY THE NETWORK OF JEWISH HUMAN SERVICES AGENCIES, COVERING AGENCIES THROUGHOUT THE US AND CANADA. BASED ON ITS EVALUATION OF THE EXECUTIVE DIRECTOR'S PERFORMANCE, THE AGENCY BUDGET, AND THE SALARY SURVEY DATA, THE COMMITTEE MAKES ITS RECOMMENDATION, THEN ADOPTED BY THE BOARD AS PART OF ITS BUDGET APPROVAL PROCESS. THE EXECUTIVE DIRECTOR AND HR MANAGER, AS WELL AS PERSONNEL COMMITTEE MEMBERS REVIEW COMPARABILITY DATA ON AN ANNUAL BASIS. THE DATA IS USED BY THE EXECUTIVE DIRECTOR IN DEVELOPING THE AGENCY'S BUDGET, WHICH IS APPROVED BY THE BOARD.
