The Alameda County Court Appointed Special Advocates (CASA) program operates under administrative auspices of the Alameda County Health Care Services Administration (HCSA). Friends of CASA has a decision-making authority over its own accounts that are kept separately from HCSA. Friends of CASA may decide to use any unrestricted reserves to make up for a budget shortfall or to supplement CASA activities. HCSA may provide input to this, but the authority to use Friends of CASA's funds is that of Friends of CASA.








