THESE FARMERS ARE THE FUTURE OF A HEALTHY, REGIONALIZED FOOD SYSTEM. OUR STAFF AND BUSINESS ADVISERS PROVIDE ONE-ON-ONE TECHNICAL ASSISTANCE, WORKSHOPS, CONNECTIONS, AND RESOURCES. THREE STRATEGIC INITIATIVES DRIVE FARMLINK'S EDUCATIONAL PROGRAMS: THE WEALTH BUILDING INITIATIVE FOCUSES ON HELPING THOSE WHO HAVE HISTORICALLY BEEN DENIED ACCESS TO LAND, CREDIT, AND EDUCATION AND HAVE HAD LIMITED OPPORTUNITIES TO BUILD WEALTH AND EQUITY IN THEIR BUSINESS AND PERSONAL ASSETS. ACTIVITIES INCLUDE ONE-ON-ONE TECHNICAL ASSISTANCE, A PEER-TO-PEER MENTORSHIP PROGRAM, AND ACCESS TO CREDIT. WE WILL ALSO LOOK AT APPLICABLE MODELS FROM AFFORDABLE HOUSING THAT ALLOW PEOPLE TO BUILD EQUITY WITHOUT PURCHASING REAL ESTATE AT THE FULL MARKET RATE. THE EQUITY ON CONSERVATION LANDS INITIATIVE PROVIDES OPPORTUNITIES FOR UNDERSERVED FARMERS TO FARM AND BUILD WEALTH ON LANDS IMPROVED WITH CONSERVATION PRACTICES OR PROTECTED BY CONSERVATION EASEMENTS. THE PROGRAM USES FINANCIAL INCENTIVES TO ENCOURAGE IMPLEMENTATION OF CONSERVATION AND CLIMATE ADAPTATION MEASURES. FARMLINK PROVIDES CREDIT AND TECHNICAL ASSISTANCE TO LANDOWNERS AND FARMERS TO FACILITATE LAND ACCESS AND ADOPTION OF CONSERVATION PRACTICES. WE PARTNER WITH LAND TRUSTS, ON-LAND ACCESS AND AFFORDABILITY, AND FINANCE FARMERS AND RANCHERS WHO WISH TO PURCHASE EASEMENT-PROTECTED LAND, AND IMPLEMENT REGENERATIVE PRACTICES. THE RESILIENCE AND SUCCESSION INITIATIVE ENSURES THAT: 1) FARMERS AND RANCHERS HAVE KNOWLEDGE AND TOOLS TO PASS LAND AND OPERATIONS TO FUTURE OPERATORS; 2) FARMERS HAVE KNOWLEDGE AND TOOLS TO CREATE AND PRESERVE WEALTH WHILE CONSERVING AND ENHANCING NATURAL RESOURCES; AND 3) RURAL COMMUNITIES HAVE RESILIENT FOOD SYSTEMS, LIVABLE-WAGE JOBS, AND A HEALTHY ENVIRONMENT CHARACTERIZED BY WORKING LANDS PROVIDING BOTH INCOME AND ECOSYSTEMS SERVICES. ACTIVITIES INCLUDE COHORT-BASED EDUCATION; ONE-ON-ONE TECHNICAL ASSISTANCE, AND ACCESS TO CREDIT.</p>
