When completed in late 2016, the historic building will include 40 apartments, a ground floor retail space, and an expanded Openhouse Information and Service Center.

Phase 2 of the construction project, scheduled to begin in late 2016, includes 79 additional units of housing and a new Openhouse Program Center. This phase will be separately financed through a community fundraising campaign.
