All four of these programs provide intensive 24/7 care, enrichment activities such as garden program, or photography class and including a wide variety of mental health services including psychiatric assessment, individual and group therapy. The youth served in these programs have experienced significant trauma and are working on significant behavioral challenges which are barriers to them living in a family environment. Over 8000 days of care were provided to 50 youth last year.
