We processed 1,252,188 donations and provided overall employment to 1,832 individuals approximately 50% of whom have a disability or other barrier to employment

 Our Mission Services division provided a variety of employment and training services to the San Diego County Community. We operate Customized Employment Services which provide vocational assessment, skills training and placement services to individuals with disabilities and other barriers to employment including military veterans, young adults, Department of Rehabilitation clients and Social Security recipients. We operate Supported Employment Services which provide vocational assessment, skills training and placement services to individuals with developmental disabilities. We operate Community Employment Centers which provide vocational assessment, skills training and placement services to anyone in the San Diego County Community who walks in wanting support. We provide Learning and Development opportunities for our employees and the community to improve employability by improving their talent and potential. All of these services are delivered free of charge to the individual recipients. In 2016 we helped 1,951 individuals find jobs.
