(Revenue \$) Operation School Bell (OSB) provides economically disadvantaged students at thirty seven (37) elementary schools of the Santa Ana Unified School District (SAUSD) with two complete school uniforms sets (white polo shirt and bottoms: shorts, skirts or pants), a jacket, underwear/boxers, toiletry kit, shoes and socks. The students also receive a new backpack filled with school supplies and a new book. OSB, located at the Assistance League of Santa Ana's facility, is the only organization providing free uniforms to children in SAUSD. The program is volunteer operated, and all contributions go directly for tangible supplies that are passed on to the students at no cost to them.

4b (Code) (Expenses \$ 108,991. including grants of \$) (Revenue \$ 7,420.) The Dental Center, located at the Assistance League of Santa Ana's facility, provides low-cost dental care to uninsured students from kindergarten through twelfth grade. This past year the chapter provided dental care procedures, which included examinations, teeth cleaning, full-mouth x-rays, fillings, root canals, and extractions. The Dental Center is staffed by licensed dentists, dental hygienists, bilingual office staff and volunteers. Patients receive individual instruction on proper oral care and nutrition and are given a dental hygiene kit by the volunteers.

4c (Code) (Expenses \$ 76,997. including grants of \$ 16,077.) (Revenue \$ 280.) Community Assistance Outreach Program provides targeted short term philanthropic services to residents of Santa Ana including holiday gifts and activities at French Park Care Center, Holiday Gift of Giving to migrant worker families, assistance to local women's shelters, Care Packages for scholarship recipients, human trafficking prevention, 211, Teen Challenge, KidsWorks, and community neighborhood meetings.

Assistance League Scholarships awards college scholarships to seniors graduating from Santa Ana Unified School District's Career Technical Education Program (CTE). Students must have teacher recommendations, the desire to attend either a 4-year college or a community college, and a financial need. Scholarships are paid after verification of enrollment on a semester or quarter basis. Many recipients are the first in their family to attend college. Each year at least 20 scholarships are awarded and presented at a spring reception at the Assistance League facility for the recipients' families, teachers, principals, and SAUSD guests.

The Monthly Food Pantry and Food Distribution program operates during Santa Ana Unified School District school breaks providing monthly emergency food pantry services to hungry Santa Ana families consisting of dry food such as rice, pasta, beans, canned soups, canned mixed vegetables and corn, peanut butter, jelly, tuna fish and cereal. The Food Distribution programs take place during SAUSD school breaks - winter, spring and summer and provides dry food and cooking needs such as cooking oil as well as fresh food such as garlic, onions, tomatoes and fruits such as apples, oranges, strawberries and bananas.
