The Boys & Girls Club of Vista serves more than 2,700 kids ages 5-18 annually at 6 program sites in Vista and Oceanside. We are open when kids need us most after school, on most school holidays and during the summer. We offer a safe and positive place for kids where they can learn, grow and succeed. Besides being primarily economically disadvantaged, the kids predominantly served in Vista are at the highest risk in San Diego County for academic failure and becoming disconnected with society. According to the San Diego Workforce Partnership, Vista has the most disconnected youth between the ages of 16-18 meaning that they are not working or not in school at 18. 6% in San Diego County. BGCV offers hope and opportunity with year-round programs that focus on academic success, character development and healthy lifestyles. Membership fees are \$50 a year per Club member and financial assistance is offered to families in need for am/pm programs, day camps, athletic programs, field trips, etc. BGCV prepares kids for high school graduation, college and careers by building the skills needed to succeed in today's globally competitive workforce. Staff and volunteers help teach kids how to be responsible citizens and resilient leaders through mentorship, accountability and modeling good behavior. Programs include academic enrichment programs and high yield learning activities, mentoring workforce development, literacy, gang prevention, music, sports & fitness and character leadership programs. Academic programs such as Power Hour/STEAM, Project Learn and Career Launch are designed to ensure that all Club members graduate high school on time and are ready for post-secondary education and a career. Summer Brain gain aligns day camps with fun, themed modules with common core anchor standards that helps decrease summer learning loss. Fast ForWord provides guided reading and language intervention through technology using a scaffolding approach. Art programs are designed to foster creativity in young people and give them outlets for self-expression. Music programs build creativity and build self-confidence and give Club members the opportunity to learn an instrument from professional instructors and bring home an instrument for free. 97% of Club members expect to graduate high school. SMART Moves is a gang prevention program that helps kids become responsible, caring citizens focusing on decision-making, anger management and building self-esteem while making a difference to the community. K-Kids is a leadership group dedicated to community service projects that focused on animal welfare as well as maternal health through UNICEF in 2018. 63% of Club teens volunteer monthly in the community. Project FUN is a daily comprehensive health and wellness program that increases daily physical activity through sports as well as teaching good nutrition and how to develop healthy relationships. Sports include basketball, volleyball, soccer, flag football and cross country. 69% of Club members are active at least five days a week.
