NINETY PERCENT OF LBCC PATIENTS ARE LIVING BELOW 200% FEDERAL POVERTY LEVEL; APPROXIMATELY 62% LIVE IN SEVERE POVERTY (2015 OFFICE OF STATEWIDE HEALTH PLANNING AND DEVELOPMENT UTILIZATION REPORT). 40 PERCENT OF PATIENTS ARE HISPANIC, MANY OF WHOM SPEAK ONLY SPANISH.
