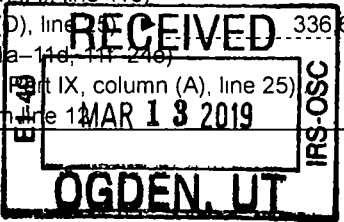

The affordable housing program provides housing to qualified low-income households, including families, seniors, farmworkers, and other special needs groups PSHHC owns 683 affordable units in three counties, providing affordable housing to over 2,021 low-income residents PSHHC affordable housing units provide housing to 130 disabled residents, 143 senior residents, 30 veteran residents and their families and 42 previously homeless residents in San Luis Obispo, Santa Barbara and Ventura Counties PSHHC believes the affordable housing program provides economic and educational opportunities to the low-income residents, leading to self-sufficiency and improving local communities

The resident services and resident education programs provide for low-income seniors and families, counseling, after-school tutoring program, health screenings, ESL classes, financial literacy programs, homeownership counseling, foreclosure counseling, and emergency financial assistance These programs are designed to help low-income persons remain housed in safe and affordable housing and to provide educational opportunities PSHHC's youth education program has 237 participants and 150 participants in the college club program that awarded 9 scholarships for participants attending colleges In addition, PSHHC provided financial literacy to 321 households and an additional 17 residents participated in financial literacy functions

During the current year, PSHHC completed construction on 24 affordable self-help homes in San Miguel, CA and began construction on an additional 19 affordable self-help homes in San Miguel, CA PSHHC continued site preparation for 40 affordable self-help lots in San Miguel, CA and 10 lots in Los Osos, CA Additionally, rehabilitation efforts continued on 83 affordable rental units in Goleta, CA, a 30 unit multifamily affordable housing project in Templeton, CA and a 34 unit multifamily farmworker affordable housing project in Santa Maria, CA PSHHC completed rehabilitation and construction efforts and moved in low-income tenants at a 60 unit multifamily affordable rental project in Paso Robles, CA, a 35 unit senior affordable rental project in Santa Maria, CA, a 40 unit multifamily affordable rental project in Santa Barbara, CA and a 70 unit multifamily affordable rental project in Goleta, CA In addition to the expenditures shown, additional costs of \$583,434 were capitalized as construction costs for affordable rental housing and self-help ownership projects
