Individuals received clothing, food, other household items, transitional counseling and support.

Schedule M-Non Cash contributions of food inventory	Food donations received included 395,351 pounds Fresh Rescue food donated by three large retail markets. Value was estimated at \$2 per pound less a 30% spoilage factor. Additional large donations included 3,675 food bags which were valued estimating average cost per bag at \$12. Smaller quantities of food donations were received at the two CCSA locations during the year. Bay Park Food Drive brought in 5,418 lbs of food.
