Approximately 410 at-risk individuals were educated through 20 workshops with 510 one-on-ones and over 235 counseling hours assisting in budgeting, credit counseling, financial literacy and homeownership. Over 2,000 resources were provided in the community with 5 families becoming first-time homeowners (73 homeowners since 2003). While Family Mentoring worked to improve economic hardships for families in need, SteppingUPs College Awareness Program worked on preventing those hardships for our future by educating at-risk students on how to get to and through college. The program has maintained its commitment to reducing the high school dropout rate in Orange County since 2006; encouraging a higher education for at-risk youth that will assist in breaking the generational cycle of poverty. The program has grown from serving 26 students to serving over 600 in 2019 where 32 high school seniors graduated on time and 100% stepping up to college.
