CVHC's mission is to help low income people improve their living conditions through advocacy, research, construction and operation of housing and community development projects. CVHC develops single family and multifamily affordable housing for low income families. We also provide an array of community services programs for our residents at our multifamily developments.

CVHC provides technical assistance to low income families in obtaining financing to build their single family home in the Coachella Valley and other communities. CVHC receives federal and state funds to assist low income families to build their homes under the Mutual Self Help Program. The total number of houses built for this period under the Mutual Self Help Program were 43, a total of 80 were in various stages of construction, and 63 lots were in family recruiting stages.
CVHC also acquires and develops land for the purpose of building affordable single family housing. A total of 545 lots are currently in the predevelopment stages.
CVHC operates a Lease to Own Program, whereby houses are purchased, rehabilitated and rented out to eligible families. A total of 44 houses were rehabilitated under this program. Four (4) houses were sold during the year. 38 houses remain under the program. CVHC also provides Housing Counseling assistance to families participating in the Mutual Self Help Program and the Lease to Own Program. A total of 423 families received various types of housing counseling services during the fiscal year.

4b (Code:) (Expenses \$ 1,306,762 including grants of \$ 594,476) (Revenue \$ 1,100,478)
CVHC acquires and develops land for the purpose of building affordable multifamily housing developments. Financing for these developments is obtained from the Low Income Housing Tax Credit Program (LIHTC) as well as federal, state, county and local funds. During the year a 75 unit multifamily low income housing tax credit development located in the City of Perris, CA was completed. We also had a 138 unit veterans housing low income tax credit development under construction. Three (3) developments were in pre-funding stages totaling 217 units. Two (2) developments were in the predevelopment stages totaling 338 units. Four (4) developments were in the preacquisition stages totaling 320 units.
CVHC has completed and Rehabilitated a total of 2,478 units of multifamily and special needs housing since its inception.

CVHC owns and operates six multifamily apartment developments, one single room occupancy apartment, and one Mobile Home Park that provide affordable housing to low and very low farmworker families and other low income families. Total number of units is 644 and 106 rental spaces. CVHC contracts with a third party management company to manage our developments.
CVHC and it's affiliated entities also owns and operate seven additional multifamily apartment developments that provide affordable housing to low and very low income families. These developments were built under the Low Income Housing Tax Credit Program (LIHTC). Total number of units owned 473

CVHC has established an Asset Management department that provides management oversight for all the multifamily developments that have been built or rehabilitated by CVHC. A total of 33 developments have been built totaling 2,478 units of affordable housing.

CVHC has established a Community Service department that provides on-going support to a variety of services provided at the apartments sites. The following services were provided:

Four (4) Head Start Centers provided services to 218 children in Palm Springs, Coachella and two (2) sites in Mecca, CA.

Three (3) Child Care Center Programs provided services to 123 children in Desert Hot Springs, Coachella and Mecca, CA.

Two (2) Pre-School Center programs provided services to 93 children in the City of Indio and La Quinta, CA.

Ten (10) After-School tutoring programs provided services to 4,385 children in Mecca, Coachella, Indio, La Quinta, Desert Hot Springs, Palm Springs and Moreno Valley, CA.

Scholarship Program assisted children of CVHC's single and multifamily housing residents to pursue higher education. A total of 103 scholarships were granted during the year. A total of \$65,250 was disbursed to scholarship recipients during this period.

Tennis Summer Camp program was provided for our apartment development's youth at Las Casas I, II and III, Desert Gardens, and Pueblo Nuevo Apartments. Approximately 65 youth participated in this activity.

Cultural Activities provided at our multifamily developments include: Mariachi music lessons, Ballet Folklorico dancing, Art Classes, and attendance at Opera Performance and Ballet Screenings. Approximately 100 to 120 children participate in these programs.

ESL (English as a second language) courses are offered in some of our apartment complexes.

Eleven (11) Computer Literacy programs provided service to 4,092 participants in Mecca, Coachella, Indio, La Quinta, Desert Hot Springs, Palm Springs and Moreno Valley, CA.

STEM (Science, Technology, Engineering and Math) programming is offered at ten (10) of our multifamily complexes. Approximately 685 children participated in this program.

Computer Access is provided through open computer sites at eleven (11) multifamily developments.

This was a no interest loan with a maturity and forgivable date of January 7, 2016. On January 22, 2016 in accordance with the amended and restated affordable housing agreement signed by CVHC and the La Quinta Redevelopment Agency dated December 1, 2007 this loan was cancelled and as a result CVHC recognized a gain on the forgiveness of this loan in the amount of \$30,147,938.
