CVHC's mission is to improve the living conditions of low-income individuals and families by constructing and operating affordable housing infused with community services programs. CVHC develops single family and multifamily affordable housing for low income families. We also provide an array of community services programs for our residents at our multifamily developments.

CVHC provides technical assistance to low income families in obtaining financing to build their single family home in the Coachella Valley and other communities. CVHC receives federal and state funds to assist low income families to build their homes under the Mutual Self Help Program (MSHP). The total numbers of houses completed for this period under the MSHP were 24, a total of 107 were in various stages of construction, and 64 lots were in family recruiting stages.
CVHC also acquires and develops land for the purpose of building affordable single family housing. A total of 291 lots are currently in the predevelopment stages.
CVHC operates a Lease to Own Program, whereby houses were purchased, rehabilitated and rented out to eligible families. A total of 44 houses were rehabilitated under this program. A total of 9 were sold during the year, 29 houses remain under this program.
CVHC provides Housing Counseling assistance to families participating in the MSHP and the Lease to Own Program. A total of 444 received various types of housing counseling services during the fiscal year.

4b (Code:) (Expenses \$ **811,921** including grants of \$ **221,009**) (Revenue \$ **1,079,814**)
CVHC acquires and develops land for the purpose of building affordable multifamily housing developments. Financing for these developments is obtained from the Low Income Housing Tax Credit Program (LIHTC) as well as federal, state, county and local funds. During the year a 138 unit homeless veterans housing low income housing tax credit development was under construction. Three (3) LIHTC developments were in pre-funding stages totaling 289 units. Four (4) developments were in the pre-development stages totaling 322 units.
CVHC has completed and rehabilitated 33 developments for a total of 2,478 units of multifamily and special needs affordable housing since its inception.

CVHC Owns and operates six multifamily apartment developments, one single room occupancy apartment, and one Mobile Home Park that provide affordable housing to low and very low income farmworker families and other low income families. Total number of units is 750 and 106 rental spaces. CVHC contracts with a third party Property Management Company to manage our developments.
CVHC and its affiliated entities also own and operate nine additional multifamily apartment developments that provide affordable housing to low and very low income families and individuals. These developments were built under the Low Income Housing Tax Credit Program (LIHTC). Total number of units owned 492.
