The goal of the initiative is to reconnect the power of education to the power of aspiration, spurring local job creation, spiking local GDP growth, and therein insuring the future prosperity of our students and our nation. HOPE Corps volunteers and Business Role Models from the local business community, colleges and universities deliver the HBIABA program in low-to-moderate income community middle and high school classrooms across the United States and soon to be launched in South Africa. HBIABA is implemented in seven vital phases: Phase I.
