FERNHURST - THERE WERE TWO PROGRAMS AT FERNHURST IN 2015 AS FOLLOWS: 1) HOMEBASE TRANSITIONAL HOUSING PROVIDED 10,492 SUBSIDIZED/DISCOUNTED HOUSING NIGHTS AND 5,133 MEALS FOR 41 WOMEN AND 4 FAMILIES. SUPPORT AND SERVICES PROVIDED TO HELP THEM OBTAIN PERMANENT HOUSING. 93% AGREED THAT ONE BARRIER TO PERMANENT HOUSING WAS REDUCED. 2) KA HALE WORK FURLOUGH PROGRAM TO FACILITATE THE SUCCESSFUL TRANSITION FOR SELECTED WOMEN FROM PRISON BACK INTO THE COMMUNITY. THIS PROGRAM, WHICH BECAME PART OF YWCA OAHU IN JULY 2015 PROVIDED 3,422 RESIDENT BED NIGHTS AND 6,236 MEALS TO 42 INDIVIDUAL RESIDENTS. 28 RESIDENTS WORKED THROUGH THE PROGRAM AND WERE RELEASED IN 2015.
