The Society is subject to unrelated business income taxes in the U.S. federal jurisdiction and the State. Tax regulations within each jurisdiction are subject to interpretation of the related tax laws and regulations and require significant judgment to apply. Unrelated business income is derived primarily from services rendered to the Hawaii Teamsters who do not meet income eligibility guidelines of the Society. For the fiscal years ended June 30, 2017 and 2016, the Society incurred taxable income (loss) of approximately \$6,000 and \$(9,300), respectively. As of June 30, 2017 and 2016, the Society had net operating loss (NOL) carryovers of approximately \$105,100 and \$111,200, respectively, to offset future taxable income which expires at various dates through 2031. As of June 30, 2017 and 2016, the Society has not recorded a deferred tax asset related to the NOL carryovers as management has determined that the realizable portion of this asset is immaterial.</p>
