Due to the method in which the misappropriated funds were recorded in the Association's financial records, as well as the unavailability of supporting documents, although the total impropriety could be quantified, the amounts included in each of the expenditure accounts could not be determined. In an effort to fairly state program services at year-end, management derived a methodology that they believed reasonably extracted estimated misappropriated costs from program services and reclassified them as misappropriation costs within management and general expenses on Line 24 of Part IX - Functional Expenses. The Association has since filed a case with the Honolulu Police Department and as of the date of this report, the case is progressing. Management has not been able to determine the duration of the impropriety nor is able to determine the ultimate impact, if any, to the financial statements as it relates to restitutions or future funding.</p>
