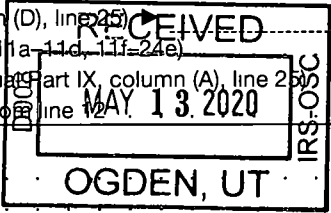

A team approach with professionals, parents and guardians is utilized.
