Postdoctoral Program Admissions

The fellowship program in Adult **Clinical Neuropsychology** is a two-year, full-time position designed to meet all of the requirements for Board Certification and a career in Clinical Neuropsychology. The training experience is based on a scientist-practitioner model that envisions the integration of all aspects of clinical neuropsychology training. The Clinical Neuropsychology Fellowship Program takes place in the new state-of-the-art Christine E. Lynn Rehabilitation Center and in the world-renowned Ryder Trauma Center. The population served ranges in age from older adolescents to end of life and from a broad range of cultural backgrounds and socioeconomic levels. Training focuses on mastering multiple models of neuropsychology assessment and intervention. Skills are attained sequentially starting with inpatient rehabilitation and then adding outpatient rehabilitation and acute services. Once mastered, the fellow will receive training in all areas concurrently rather than rotating between services. As the fellow progresses, additional supervision, teaching, presentation, and administrative responsibilities are added. The neuropsychology fellows receives a minimum of 2 hours of face-to-face supervision per week, as well as extensive informal supervision. Supervision is provided by all attending neuropsychologists and rehabilitation psychologists based on which service the patient is on. Fellows who are bilingual in English and Spanish will have the opportunity to provide assessment and intervention to patients and families in Spanish on all services. They also will have the opportunity to receive supervision by experienced bilingual clinicians.

Our program fits best with postdoctoral fellows who have been trained as scientist-practitioners or clinical scientists at the graduate level, and have professional interests and internship experiences consistent with the focus area of clinical health psychology. Candidates must come from an APA accredited doctoral (PhD or PsyD) program in the area of clinical or counseling psychology and completion of an APA-accredited or APPIC membership internship site.
