DATA CONTROLLER

The Data Controller is JBM Campllong, S.L., with Tax ID (CIF) B17419292 and registered office at Crta. Aeroport Km 1-6, Nave 2,2 – CP 1785, Vilobí de Onyar (hereinafter, "JBM"). Our company details appear in the Legal Notice of this website.

PRINCIPLES OF DATA PROCESSING

- **Lawfulness, fairness and transparency:** Your consent will always be required to process your data for one or more specific purposes, which will be clearly communicated in advance.
- **Data minimization:** Only the data strictly necessary for the intended purposes will be requested.
- **Storage limitation:** Data will be kept only for as long as required for the purposes for which they are processed.
- **Integrity and confidentiality:** Your data will be processed in a manner that ensures appropriate security and confidentiality. JBM takes the necessary precautions to prevent unauthorized access or misuse by third parties.

HOW WE OBTAIN THE DATA WE PROCESS

The data processed by JBM through this website are collected via the SIM code entered in the verification form provided for this purpose. Additionally, geolocation data provided by the purchased beacon may be automatically collected through the use of the device by the Data Subject, in accordance with the technical specifications detailed on our purchase website, product datasheet, or user manual.

WHAT DATA WE PROCESS

We may process location or inferred geolocation data:

- (i) from the use of the beacon by the User, or
 - (ii) through the SIM code entered by the User in the verification form on this website to check that the beacon is functioning properly.
- In both cases, the beacon automatically provides the exact coordinates of its location.

If the Data Subject has any doubts regarding this section, they should contact JBM at the address indicated in the "Data Controller" section.

PURPOSES OF DATA PROCESSING

- To verify the correct functioning of the product.
- To geolocate the activated beacon and, therefore, the broken-down vehicle and the Data Subject themselves, communicating their GPS coordinates to the DGT in accordance with Royal Decree 1030/2022 of December 20, amending Royal Decree 159/2021 of March 16 on roadside assistance services..

DATA RETENTION PERIOD

The personal data provided by the beacon and displayed on the website are temporary: all location data collected through the SIM code verification form or through the use of the beacon are deleted every 24 hours.

LEGAL BASIS FOR PROCESSING

The legal basis is the consent of the Data Subject (Art. 6.1.a GDPR), granted by accepting this policy by checking the box in the verification form, as well as the fulfillment of a legal obligation applicable to the Data Controller (Art. 6.1.c GDPR).

DATA RECIPIENTS

The data obtained through the beacon may be shared with JBM's service providers (e.g., technology or customer support providers) acting as data processors, who have demonstrated adequate data protection measures.

DATA TRANSFERS

Data may be transferred to the Dirección General de Tráfico (DGT) in compliance with Royal Decree 1030/2022, and to law enforcement agencies and judicial authorities when required by applicable legislation to comply with legal proceedings, investigations, or to protect the safety of individuals and defend legal claims.

DATA SUBJECT RIGHTS

You have the right to:

- Obtain confirmation as to whether your data are being processed.
- Access, rectify inaccurate data, or request erasure when they are no longer needed.
- Request the restriction of processing.
- Object to processing for reasons related to your particular situation.

In such cases, JBM will stop processing your data unless there are compelling legitimate grounds or for the exercise or defense of legal claims.

JBM will notify recipients of any rectification, erasure, or restriction of processing, unless this requires disproportionate effort. Upon request, you will be informed of those recipients.

You also have the right to receive your personal data in a structured, commonly used, and machine-readable format, and to transmit them to another controller when processing is based on consent or a contract and is carried out by automated means.

You may object at any time to processing based on public interest or legitimate interest, including profiling, unless there are compelling legitimate grounds. You also have the right not to be subject to automated decision-making that produces legal effects or significantly affects you, except as permitted by law.

Finally, you have the right to file a complaint with the relevant Data Protection Authority.
