

22ND ANNUAL GUARDIANS OF THE CHILDREN LUNCHEON AND FASHION SHOW, PRESENTED BY DADE COUNTY FEDERAL CREDIT UNION, RAISES \$837,000 TO SUPPORT THE MIRACLES MADE DAILY AT JACKSON HEALTH SYSTEM – Proceeds to benefit Holtz Children’s Hospital –

For 22 years, Jackson Health Foundation’s Guardian Angels have supported Holtz Children’s Hospital through their annual Guardians of the Children Luncheon. On Tuesday, November 23, more than 500 philanthropists and community leaders gathered at the Ritz-Carlton Key Biscayne to raise funds for patients in need at Holtz Children’s Hospital, and honor family patriarch Abel Holtz, who passed away in July.
